CLOSURE ORDER FOR THE 14<sup>TH</sup> JUDICIAL DISTRICT COURT FOR CALCASIEU PARISH

Acting pursuant to Article V, Section I, of the Louisiana Constitution of 1974, as amended, and the inherent power of this Court:

IT IS HEREBY ORDERED that:

The 14<sup>th</sup> Judicial District Court for the Parish of Calcasieu, in recognition of the State Declared Holiday of Juneteenth, shall be closed on Friday, June 20, 2025 and will reopen for business on Monday, June 23, 2025.

IT IS FURTHER ORDERED that pursuant to R.S. 1:55.1 the third Saturday in June, Juneteenth Day, has been declared a day of public rest and a legal holiday, and pursuant to R.S. 1:55 (B) (4) when a holiday falls on a full-time employee's regular day off (Saturday), the holiday shall be the closest regularly scheduled work day preceding or following the legal holiday, therefore the Court shall be closed on Friday, June 20, 2025, and this day is declared a legal holiday.

IT IS FURTHER ORDERED that pursuant to the declaration signed on May 2, 2025, by Governor Jeff Landry, declaring that the State of Louisiana shall observe Juneteenth Day in conjunction with the federal holiday as a legal holiday on June 19, 2025, the court recognizes June 19, 2025, as a <u>filing holiday</u> and all filings due on June 19, 2025, shall be deemed timely filed if filed on or before Friday, June 20, 2025, since the Calcasieu Parish Clerk of Court will be closed on Thursday June 19, 2025, but will be open on Friday June 20, 2025. Further, employees of the Judiciary are required to work on June 19, 2025, to maintain an efficient operation. Further the employees of the Judiciary shall celebrate the legal holiday on Friday, June 20, 2025.
